WHAT IS THE INDIAN INCENTIVE PROGRAM (IIP) PROGRAM?

The Indian Incentive Program is a congressionally sponsored program that provides a 5% rebate to a prime contractor on the total amount subcontracted to an Indian-Owned Economic Enterprise or Indian Organization in accordance with [DFARS Clause 252.226-7001](#). Overall, this program serves to preserve free competitive enterprise and to maintain and strengthen the overall economy of our nation.

What are the contract requirements?

- DoD contract must be \$500K or more
- For prime contract IIP requests, the contract must include DFARS clause 252.226.7001. *Contract/subcontract may be modified to add the clauses prior to completion of contract performance upon request of the prime contractor.
- IIP funds must be submitted BEFORE the contract is closed out.

Who can participate and request IIP funds?

- Large business prime contractors
- Small business prime contractors (no subcontracting plan required).
- DoD sub-tier contractors (at any tier).

How to Claim IIP Funds:

The Dept of Defense, Office of Small Business Programs provides the IIP letter templates referenced below. They can be downloaded via <https://business.defense.gov/Programs/Indian-Incentive-Program/IIP-Documents/>

Steps to use the IIP Program:

Step 1: Prime utilizes Arrowhead Global (Native owned company) as a subcontractor to provide products & services for a DoD contract.

Step 2: Prime submits letter to Contracting Officer (KO) requesting IIP Rebate. (Sample letter available via www.arrowheadglobal.com/resources.)

Step 3: KO submits request w/ required documentation to OSBP.

Step 4: OSBP performs review & verification.

Step 5: Military Interdepartmental Purchase Request (MIPR) for IIP payment is initiated.

Step 6: MIPR accepted by Contracting Activity.

Step 7: Contract Modification Issued for IIP Rebate by KO.

Step 8: Prime Submits Invoice per MIPR Instruction (Sample Invoice available via www.arrowheadglobal.com/resources.)

Step 9: Prime Receives IIP Rebate Payment!
